In accordance with Title IV regulations, the University of Idaho is required to obtain consent to use Title IV financial aid funds to other educational related institutional charges, such as books, health insurance, and other miscellaneous fees. Title IV financial aid includes aid from the Direct Loan, Pell Grant, Supplemental Educational Opportunity Grant (SEOG), PLUS Loan, Perkins Loan, and TEACH Grant programs. An authorization is not required to apply federal financial aid funds to current tuition and fee charges, and towards room and board charges if you live on campus and/or have a meal plan.

If Title IV financial aid funds exceed the sum of allowable charges, the University of Idaho must return excess funds to the parent or student borrower. With the parent or student loan holder's authorization, the University of Idaho can apply excess funds to non-tuition and fee charges (such as parking fines, late registration fees, student health visits, and parking permits). In compliance with federal regulations, should a Parent PLUS loan create Title IV excess, then it is the determination of the **parent borrower** on how excess funds are to be utilized. If you are receiving Federal financial aid in excess of allowable charges, you may authorize the University of Idaho to use these funds to pay other current charges or pay up to \$200.00 of other prior year charges.

You may refuse to authorize any of the options listed below. You may also update your authorization any time by completing another form and turn it in to the Student Accounts office. Your initial authorization response will remain in effect the entire time you are enrolled at the University of Idaho, or until a new form is received, rescinding the authorization.
