- Current Policy Dress code: No open toed shoes. Long pants (appropriately fitted, neat clean appearance). Shirts, No Logos (with exception on FFA or 4-H), shirt must have collar and length be long enough that no midriff is showing, sleeves may be short or long, but no cap sleeves. Same dress code for Sale Ring. No glitter, bows, etc. on animals.
- 9. New Policy No open-toed shoes. Long pants -appropriately fitted, neat, clean appearance. No sweatpants or leggings. Shirts Brand name and manufacturer's logos to be no bigger than 2". FFA and 4-H logos, regardless of size, are allowed. No sweatshirts/hoodies. No T-shirts. No midriffs allowed. Sleeves may be long or short, but shoulders should be covered. Same dress code for Sale Ring. No glitter, bows, etc on animals. No riding the animal.
- 10. Justification If we had followed the current rules, several girls would have been in violation of the current dress code including the Champion Beef Showman and the Junior Sheep Showman. Updating the current rules will ensure kids are able to wear current trends and not be held to outdated rules.
- 11. If the rule does not change, then we need to educate our youth and leaders about the rule and follow it every year. Why have rules if we don't follow them? Or pick and choose when we want to follow them or not??
