Mutual Termination of Football Game Agreement

This Mutual Termination Agreement is entered into this 23rd day of December 2024, by and between **The Regents of the University of Idaho** (“University”) and **University of St. Thomas (Minnesota)** (“St. Thomas”).

WHEREAS, the University and St. Thomas are parties to the Football Game Agreement dated January 15, 2022, pertaining to games scheduled for September 6, 2025, and September 18, 2027;

AND WHEREAS, Clause 15(a) of the Agreement permits mutual termination by both parties;

AND WHEREAS, both parties have mutually agreed to terminate the Agreement in accordance with Clause 15(a);

NOW, THEREFORE, the University and St. Thomas mutually agree as follows:

- 1 **Termination of Agreement** The Football Game Agreement between the University and St. Thomas, dated January 15, 2022, is hereby terminated effective December 23, 2024.
- 2 **Mutual Release** Both parties agree to release each other from any and all obligations, claims, or liabilities arising from or related to the Agreement.
- 3 **Future Opportunities** The University and St. Thomas express their commitment to maintaining a positive relationship and exploring future opportunities for collaboration.
